

This Privacy Policy sets out the rules for the processing of personal data and the conditions of confidentiality of users of the website located at <https://bmweybrows.com>. The administrator of personal data in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27.04.2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC, in regarding personal data of Users who are natural persons is:

#### 1. Method of collecting personal data.

Personal data collected on the [bmweybrows.com](https://bmweybrows.com) website is provided directly by the user by completing the order form available online, and when creating an account on the site as well as during email or telephone contact. Providing personal data by website users is voluntary, but it is necessary for transactions concluded via the [bmweybrows.com](https://bmweybrows.com) website and [qbsolutions.eu](https://qbsolutions.eu).

#### 2. The scope of personal data collected.

**Sellers' data** - When registering the seller's profile on [bmweybrows.com](https://bmweybrows.com) and [qbsolutions.eu](https://qbsolutions.eu), the user will be asked to provide their name, company or brand name, email address, telephone number, tax identification number and exact address details.

**Buyers' data** - The User who purchases products offered by the Sellers on the [bmweybrows.com](https://bmweybrows.com) website will be required to provide: name and surname, e-mail address, contact telephone number, home address, shipping address. If the user decides to set up a profile on [bmweybrows.com](https://bmweybrows.com) - the operator will also process the history of orders placed by the buyer.

**Data collected in the event of telephone or email contact** - In the event of telephone or email contact, the user may be asked to provide the name and surname and contact telephone number or return email address.

#### 3. Purpose of collecting data.

Users' personal data is collected in order to enable Buyers and Sellers to carry out purchase and sale transactions through the [bmweybrows.com](https://bmweybrows.com) website.

The personal data of the sellers are also used to promote the products they offer on the [bmweybrows.com](https://bmweybrows.com) website and to settle accounts with the [bmweybrows.com](https://bmweybrows.com) website operator.

Data of buyers who have decided to set up a profile on [bmweybrows.com](https://bmweybrows.com) are processed with their consent in order to simplify the ordering process.

The email address entered in the service / product order form will be used to send mailing with the website operator's promotional offers, provided that the user has agreed to receive it. Personal data that the user provides when contacting by email or phone with the operator of the [bmweybrows.com](https://bmweybrows.com) website will be used solely to answer the user's query.

The data collected automatically by the [bmweybrows.com](https://bmweybrows.com) operator's IT system will be used only for statistical purposes.

#### 4. Sharing personal data.

The buyer's personal data collected by the operator of the [bmweybrows.com](https://bmweybrows.com) website will be made available to the seller in order to enable the finalization of the transaction concluded via the website.

If the buyer chooses a shipment of goods via courier or Poczta-Polska - the website operator will provide these companies with the data of both parties to the transaction in order to enable the receipt and delivery of the product. company, correspondence address, phone number indicated by the sender / recipient.

If the buyer chooses the payment method supported by the PayU SA website, the website operator will provide this company with data on both parties to the transaction in order to enable

payment settlement and product purchase.

In the event of a suspected breach of law, personal data will be made available to relevant state authorities and, in the event of an inspection, also to authorized employees of the Inspector General for Personal Data Protection.

The operator of the bmweyebrows.com website does not under any circumstances resell or disclose personal data to third parties except as described above.

#### 5. Contact.

The operator of the bmweyebrows.com website will contact the users via e-mail and telephone in matters related to the purchase and sale transactions concluded via the website. Users will be provided with: order confirmation, information about the order placed, reports on the stages of the order, invoices as well as information related to the complaint process, if the user has joined such a process. Information will be sent by e-mail and in the event of the user's consent by short text messages - sms. Users who have agreed to receive the newsletter, the operator of the bmweyebrows.com website will send it via e-mail. The user may at any time unsubscribe from the newsletter, using the appropriate link in the footer of the newsletter.

#### 6. Data change.

Each user has the right to change or update their personal data by sending an instruction to the operator of the bmweyebrows.com website by e-mail to the following address: [contact@bmweyebrows.com](mailto:contact@bmweyebrows.com). The user may at any time opt out of receiving marketing e-mails from the operator or prohibit the transfer of his personal data to third parties (courier companies), provided that the ban does not apply to the transaction being carried out. The resignation decision should be notified to the operator of the bmweyebrows.com website by email at [contact@bmweyebrows.com](mailto:contact@bmweyebrows.com). Cancellations will be considered by the operator of the bmweyebrows.com website as soon as possible after receiving it. In addition, the user may also opt out of receiving marketing e-mails from the operator by clicking the link at the bottom of each e-mail.

#### 7. Cookies.

The operator of the bmweyebrows.com website uses cookies to enable logging in to the account on the Website, monitor users' traffic on the Website, and compile statistics on the use of the Website. #### 8. Data security.

The operator of the bmweyebrows.com website makes every effort to effectively protect processed personal data. Personal data transferred from the website to the operator's server has been secured by an encrypted SSL connection. Only persons having a written authorization to process personal data in the operator's system have access to personal data processed in the system operator's system. The website operator has registered the identified personal data sets in the register of the Chief Inspector for Personal Data Protection.

#### 9. Responsibility.

The bmweyebrows.com website operator undertakes to apply the principles described in this document that guarantee confidentiality to website users. It is permissible for the situation in which the scope of the data collected or the way it is secured to change slightly while maintaining the privacy of users. This document may not give rise to any claims against the operator of the bmweyebrows.com website, provided that these claims do not result from applicable law in the territory of the Republic of Poland.
